Description	 The assistant's duties will include: organizational activities for the Department, Faculty, and University; undertaking administrative tasks related to the research process; publishing of popular science articles and scientific publications; carrying out research within scientific projects; conducting activities in the scientific discipline of animal science and fisheries, including scientific research and publication of scientific articles. The candidate is expected to have a predisposition to work with students, availability and creativity, a high personal culture, the ability to work on tasks and teamwork, and constant improvement of professional competencies.

The candidate is required to meet the following qualification criteria:

- master's degree in biotechnology or zootechnics,
- knowledge of molecular biology techniques;
- experience in laboratory work, ability to operate laboratory equipment;
- professional competences documented by training and/or courses;
- English, spoken and written, at a level that allows cooperation in an international team and conducting classes in English, as well as publishing scientific articles
- in the case of foreigners, the command of the Polish language, spoken and written, is required to the extent that enables conducting classes with students.

INFORMATION CLAUSE

Pursuant to Art. 13 of the general regulation on the protection of personal data of 27 April 2016 (Journal of Laws UE L 119 of 04/05/2016) on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / WE - general regulation on data protection (Journal of Laws UE L 119/1 of 04/05/2016), Bydgoszcz University of Science and Technology informs that:

- 1. The administrator of your personal data is Bydgoszcz University of Science and Technology with its registered office at Al. prof. S. Kaliskiego 7, 85-796 Bydgoszcz,

- 3. Your personal data will be processed:
 - 1) for the purposes of the currently announced recruitment pursuant to Art. 6 sec. 1 lit. b of the general regulation on data protection of April 27, 2016 and the Labor Code of June 26, 1974 in order to conclude a contract,
 - 2) for future recruitments if you give your consent pursuant to Art. 6 sec. 1 lit. a of the regulation, expressed in writing for the period specified in the consent declaration,
- 4. Your personal data, in the event of failure to conclude the contract, will be kept for a period of up to 6 months or the time specified in the consent statement,
- 5. The recipients of your personal data will only be entities authorized to obtain personal data on the basis of legal provisions and entities cooperating in the recruitment process, your data will not be transferred to a third country, except for cases resulting from your express request,
- 6. You have the right to request the administrator to access your personal data, the right to request rectification, deletion or limitation of processing, the right to object to the processing, the right to transfer data, and if consent is granted, the right to withdraw it in any time,
- 7. Providing personal data for ongoing recruitment is a statutory requirement of the Labor Law. The consequence of not providing data is exclusion from recruitment.
